hereby states as follows:

The Defendants' Motion requests a court order for the
Commonwealth to provide any information regarding agreements

any agreement not to prosecute in exchange for testifying at
the trial.

Polygraph test are inadmissible at trial anyway.



Finally, all the facts alleged in the Motion are totally irrelevant as there has never been an agreement between the Commonwealth, Mr. Roy Kidd, or his attorney not to prosecute Mr. Kidd.
